- Meeting called to order by Ms. Pulling at 7:05 P.M.
- The Commission discussed making changes to the agenda once it has been posted.
- Mr. McKane made a motion to approve the agenda. Mr. Snee made a second to the motion. Motion passed unanimously.
- The Commission discussed changes to the July 7, 2016 minutes. Mr. Cohen made a motion to approve the minutes as corrected. Mr. Burgess made a second to the motion. Motion passed 5-1, Mr. Stearns abstaining.

New Business:

Thomas Resubdivision:

- Ms. Pulling reported Key Collision's Attorney Mr. Jim Goss wants to present a revised permit application and a final plat on Thursday, August 18, 2016. Ms. Pulling read Town Attorney Mr. Kevin Brown's opinion on the issue as well as waiving the permit fees for the revised application. Ms. Pulling asked the Commission to consider a date certain for a final hearing. Mr. Cohen made a motion to schedule the final hearing for Thursday, August 18, 2016. Mr. McKane made a second to the motion. Mr. Cohen said the Attorney's need to get the materials to the Commission so the warning can be posted and abutters notified 15 days before the final hearing per state statue, no later than Tuesday, August 2, 2016. Motion passed unanimously.
