As many of you know by now, our budget did not pass on Town Meeting Day, nor did the bond for our second floor. Since the voting results were announced, the board has been busy meeting with residents to get a sense of why the budget did not pass, as well as what changes to make before we try again.

One of the main themes we heard was that we need to do a better job getting information out to voters. In response, we will start announcing meetings on Front Porch Forum, in addition to our school's webpage (rts.grcsu.org), the Town Hall office, the Rutland Town School front office, and the GRCSU central office (now located next to Price Chopper in West Rutland). We also plan to put more information at the town transfer station in Northwood Park.

Barks and Ballots

Rutland Town voters approved our proposed departmental budgets for the '24-'25 fiscal year at this year's Town Meeting. We would all like to extend our gratitude for allowing us to continue to serve you.

At the same time, the school budget and proposed bond did not pass. Due to this, we will be conducting another election to vote again, this time, solely on the school budget.

Much like the vote for the Town's Public Safety Building, the vote on the school budget will look similar. Since the school budget weighs so heavily on our property taxes, it only makes sense to ask every property taxpayer his or her opinion.

Therefore, we have decided to mail a ballot out to every active voter in the town to give them the opportunity to voice his or her thoughts.

The election will take place on Tuesday April 30 and be held at the same polling locations as usual in the town. Members of the Board of Civil Authority will be present at Town Hall as well as at Rutland Town School to give voters the option to vote on this matter in person.

Questions about the school budget should be directed to the members of the School Board and questions about the specifics of the election process should be directed to staff at Town Hall.

While you are out voting stop by Town Hall and register those dogs! Licensing is due by April 1st. Any dog registered after that requires us to charge a fee.

Thanks to the voters of Rutland Town for your continued and generous support of Rutland Free Library on Town Meeting Day.

Free eclipse glasses

Yes! Rutland Free Library will be handing out free glasses to view the April 8 solar eclipse. At this point, we're not 100 percent sure of the how or when, so please watch our website and social media for more information.

You may have heard the state Department of Tourism announcement that libraries would be issuing free solar eclipse glasses. Unfortunately, they grossly underestimated demand, and libraries including RFL were left scrambling to meet the promises made by the Tourism folks. Thanks to Tom Estill for pointing us toward a grant from Solar Eclipse Activities for Libraries and to the Nella Grimm Fox Fund for providing us with programming support, we came up with 1,000 pairs.

Tom, who is an official NASA ambassador among many other titles, will be presenting a talk on the eclipse in Depot Park as it happens on the afternoon of April 8, and the library will be streaming the NASA feed in the Fox Room in case of cloudy weather.

Tax forms

In another case of the library picking up what the state drops, yes we have tax forms available at the help desk. The IRS only sent a few dozen copies of the standard 1040; plenty to date for seniors and in Spanish, and a good supply of books. They no longer send out any schedules or other forms.

The state has not sent out forms for several years. We can generally help you get to the forms you need. Please be patient, as we do not get any training from Vermont Department of Taxes, so we're working through their website, same as you.

RFL will print any forms, state or federal, for 25 cents a page to cover printing costs. To get forms for free, get assistance filling them out, or get contact info for either tax department, please see the slide on the front page of our website at www.rutlandfree.org.

Highway Happenings

I have to say Mother Nature has been very good to us this season. We are by no means out of the woods but spring is definitely around the corner.

I would like to thank all of the town residents that voted to approve the municipal budget on Town Meeting Day. The Department Heads of this town worked very hard to submit fiscally responsible budgets that provide the services the Town has come to expect.

We have responded to 29 winter events at this point in the winter season. Our Highway Crew and Contracted Road Crew have done very well this season. Everyone has worked together and I am proud of the work done this winter.

As we draw near to spring, we have begun planning the summer workload. We have around two miles of paving planned for the spring and summer. I have applied for a paving grant from the State of Vermont. If we receive the grant we will add another half of a mile of paving. Fingers crossed!

The Post Road sidewalk is slated to be finished this spring or early summer.

The Highway crew conducted a thorough inspection of all the culverts in town last fall/early winter. We have many culverts to clean and several that need to be replaced. There is more maintenance than can be completed in a year so this will be an ongoing project.

A quick reminder that Green Up Day is Saturday May 4. We will have Green Up bags available at the town's Transfer Station as soon as we get them.



RTS Featured on WCAX





In a March 20, 2024 article and news segment featured on WCAX, students at Rutland Town School demonstrated learning to make an impact with hands-only CPR. Here are some highlights from the article:

"Talking to some of the students just now they said, 'You know, I hope I never have to do this. But if I do, at least I know the first step in saving somebody's life,'" said Rutland Town School Principal Sarah Tetzlaff.

"If anything, it brought them awareness on to do — at least to pick up the phone and call somebody or to attempt. 40% of people don't know anything about CPR, and now we just educated two grade levels to at least be able to attempt and take that first step to maybe help save someone's life," said Michael Rowe, a Rutland Town PE and health teacher.

"I think eventually we would love to have all our middle school kids fully trained in CPR and first aid and this is just one step to getting them there," Tetzlaff said. School Board continued from pg. 1

Most of our meetings are also recorded by PegTV.

Additionally, we learned that some people voted down the budget out of principle as a way to tell Montpelier that they are not happy with the new pupilweighting formula or other mandates and their effect on property taxes. We agree with you, however, if we do not pass a budget by July, we will be forced by the state to use 87% of this year's budget, which would potentially translate to losing bus transportation, athletics, and maybe even some grades from the school. We cannot let that happen! The RTS Board wants you to know that the budget we presented had very little added by the board. One item was funding for their overnight 7th grade trip and another was bringing back Lifetime Sports. We wanted to make sure these programs were accessible to all families, and taking these out will affect the tax rate less than a penny.

Lastly, we added a second kindergarten paraeducator to support our students' learning. The other increases in the budget were contractual or inflationary, no frills at all. We hope the revised budget that we present to you in April will be approved so that we do not need to make painful cuts and can continue to make Rutland Town School the gem that it is. Please vote! "The Tax Man Commeth" April 15, 2024. When filing your Vt State Taxes, please remember that your HS-122 Homestead filing must be done by April 15th.

An extension for filing income tax returns does not relieve a property taxpayer of the obligation to file a timely Homestead Declaration (HS-122) by April 15th. Should you miss this date, you will be penalized by the state, and you may not be eligible to receive the State Income Sensitivity payment.

Applications for a Veterans exemption must be filed with the Vermont Office of Veterans Affairs before May 1st. FROM THE RUTLAND TOWN DELINQUENT TAX COLLECTOR

As folks may have noticed, this year saw an increase in delinquencies, not outrageous but an upward jump from previous years. As your CODT, I have worked with many taxpayers to assist in getting them current and back on track.

This is only a personal observation, but the pressure of increased costs seems to be affecting more and more of the working class and retirees in our town and I am concerned that if we, as a town, do not carefully address this growing budget spiral which seems to assume that we all can afford taxes rising every year, including this one, we will surely, over time, cease to be the very affordable town to live and prosper within.

Since I nave been elected to deal with tax delinquencies I have decided on a particular strategy to try and deal with this dilemma. Along with a few fellow citizens we are beginning the formation of an organized group of concerned taxpayers into an association to be formally recognized by our government leaders. Our goal is to be proactive in continuing to make Rutland Town an affordable place to live and work.

As you are well aware, our recent School Budget and Bond was voted down by a margin of 578 YES - 609 NO on the budget and 500 YES - 687 NO on the bond. When we revoted on the additional money for the Public Service Building, we felt that the large total dollars we were asking the voters to approve was significant enough that everyone should have an opportunity to vote, thus we mailed every voter a ballot. The town thought that having the largest majority of taxpayers weighing in on such an amount would give us good direction on how to proceed. In order for this to occur, it was apparent to us that we should mail ballots to every taxpayer in the town, and so we did.

The School budget and Bond that was voted down was \$14,694,628, an amount that is three times the amount of the Public Service Building and amounts to over 85% of your total tax obligation. Surely we would want the greatest number of citizens deciding such a large amount of tax dollars

At such time as the Board decides on a revised budget proposal, we certainly should use the same procedure as we did for the Safety building and mail the ballots to every taxpayer. That would certainly give our board clear guidance from the majority of our citizens.
